

Ground broken for Palmer-Donavin House

Groundbreaking was held on April 27th for the new respite care facility slated for McDowell Road in Grove City. The Palmer-Donavin House is being developed to commemorate the 100th anniversary of the Palmer-Donavin



Manufacturing Company.

It will be donated to Franklin County Residential Services, Inc. (FCRS), which will operate a temporary care program there for up to eight individuals.

"From a personal standpoint, I was completely overwhelmed by this gift," said Ed Harper, Executive Director of FCRS. He estimates the \$750,000 facility will be ready for occupancy in the fall.

"We thought this was a great way to give back to the community," explained Ron Calhoun, President of Palmer-Donavin. He noted the firm has "a long history of supporting mental retardation."

The project is being funded by Palmer Donavin as well as many of its vendors and business partners, including Crane Plastics and the GLOW Foundation.

According to FCBMRDD Superintendent Jed Morison, the

facility will help further the goal of keeping families together.

"When there is the opportunity to support families, it really makes a big difference. We're just delighted."

State budget approved

House Bill 119, known as "the budget bill," became effective on July 2nd. The legislation passed the Ohio House and Senate by nearly unanimous votes, and was signed into law by Governor Ted Strickland.

The budget will be for the 2008 and 2009 fiscal years and includes several provisions related to MRDD services.

With implementation of the bill, the *Martin* lawsuit, initially filed in 1989, will be settled. The bill includes funding for 1,500 Medicaid Individuals Options waivers which will be distributed across the state next year.

Other provisions of the bill include: extension of priority groups for waiver enrollment for the next two fiscal years; an increase in the ICFMR reimbursement rate by 2%; establishment of the Medicaid Buy-In program; restoration of dental, psychological and chiropractic services; and the establishment of a Medicaid administrative office whose executive director will report directly to the governor.

The bill removed a section of law relating to contracting authority of county boards for Medicaid services

and clarified responsibilities of the boards and the State to provide matching funds for waiver programs.

The law also establishes an MRDD Futures Committees, which will make recommendations on issues related to services for people with developmental disabilities. Twenty-two persons will serve on the committee.



Replacement levy proposed for March

Plans are moving forward for a MRDD replacement tax levy to go on the Franklin County ballot on March 4th of next year.

FCBMRDD is proposing a levy of 3.5 mills that would replace two existing levies which total 3.97 mills. Even though the total voted millage would be less under this proposal, the new effective rate of the millage would provide additional funds to allow for continued FCBMRDD services.

The owner of a \$100,000 house would contribute an additional \$39.81 per year or \$3.32 per month.


The Franklin County Commissioners will receive the proposal and are expected to ask their Levy Review Committee to analyze it over the next several months. The Commissioners' approval will be necessary by mid-December in order for the proposal to go on the March ballot.

FCBMRDD has not been on the ballot since 2001.

Charles Plumb was a U.S. Navy jet pilot in Vietnam. After 75 combat missions, his plane was destroyed by a surface-to-air missile. Plumb ejected and parachuted into enemy hands. He was captured and spent six years in a Vietnamese prison. He survived the ordeal and now lectures on lessons learned from that experience.

One day, when Plumb and his wife were sitting in a restaurant, a man at another table came up and said, "You're Plumb! You flew jet fighters in Vietnam from the aircraft carrier Kitty Hawk. You were shot down!"

"How in the world did you know that?" asked Plumb.

"I packed your parachute," the man replied. Plumb gasped in surprise and gratitude. The man pumped his hand and said, "I guess it worked!" Plumb assured him, "It sure did. If your chute

hadn't worked, I wouldn't be here today."

Plumb couldn't sleep that night, thinking about that man. Plumb says, "I kept wondering what he had looked like in a Navy uniform: a white hat; a bib in the back; and bell-bottom trousers. I wonder how many times I might have seen him and not even said 'Good morning,' or anything because, you see, I was a fighter pilot and he was just a sailor."

Plumb thought of the many hours the sailor had spent carefully weaving the shrouds and folding the silks of each chute, holding in his hands each time the fate of someone he didn't know.

Everyone has someone who provides what they need to make it through the day. We rely on many
