# Scholarship applications due

---

Interested in applying for a scholarship from the John J. Siebold Memorial Scholarship Program? If so, you must complete and submit your application to ARC Industries by Friday, May 11th.

To be eligible, an applicant must be employed by FCBDD for a minimum of one year, have a high school degree or equivalent, be pursuing a college

degree (any level) in a field related to developmental disabilities, and be either a U.S. citizen or permanent resident.

John J. Siebold, for whom the scholarship is named, was a 27-year employee of FCBDD who died unexpectedly in June, 2003. At that time, he was Operations Director of ARC Industries.

Scholarships are awarded in the amount of \$1,500 annually at the discretion of the scholarship committee. The committee has awarded a total of \$74,000 since 2004.

## FCRS plans PDP changes

---

Franklin County Residential Services, Inc., (FCRS) is in the process of making some infrastructure improvements to the Parent Directed Program (PDP). The changes are responsive to suggestions from the Ohio Department of Developmental Disabilities (DODD).

Currently FCRS receives in-kind support for the program from the Franklin County Board of Developmental Disabilities (FCBDD) administrative support staff. Also, FCRS uses multiple Medicaid billing rates. DODD has suggested that FCBDD end its in-kind support and that the program adopt administrative procedures similar to other Medicaid providers.

FCRS is implementing these changes with the establishment of a separate not-for-profit organization that will employ the direct service workers. Administrative support staff will be housed at FCRS offices at 1021 Checkrein Avenue by September 30th, and new administrative procedures will be operational by June 30th.

According to Ed Harper, Executive Director of FCRS, the transition should not present major changes for the individuals served, their family member or providers except that the location of the administrative activities will change.

# Non-Medicaid services policy adopted

At its monthly meeting on April 26th, the Franklin County Board of Developmental Disabilities adopted a new policy titled "Non-Medicaid Adult Services."

The policy places conditions on the receipt of county-funded services by adults. The chief requirement of the policy is that adults receiving

county-funded services must apply for Medicaid home and community based services, and if determined ineligible for Medicaid, they would be required to pay up to 50 percent of the cost of services.

"This policy will allow us to stretch our dollars further by ensuring the maximum use of available federal

funding," said FCBDD Superintendent Jed Morison.

## Focus on SELF waiver

The Ohio Department of Developmental Disabilities (DODD) has announced federal approval of a new waiver. The Self Empowered Life Funding (SELF) waiver will enable individuals with developmental disabilities to direct where and how they receive waiver-funded services.

Here are some highlights:

### ***When will the waiver begin?***

Enrollment is expected to begin in July.

### ***What is the waiver's capacity?***

The capacity is up to 500 individuals in the first year, increasing to 1,000 in the second year and 2,000 the third year. Note that the capacity includes 100 children with intensive behavioral needs.

### ***Who is eligible?***

Individuals must meet ICF/DD level of care requirements and be willing to participate in self-direction. A pre-screening tool will be completed prior to enrollment. The 100 children with intensive behavioral needs must meet the criteria outlined on the Children with Intensive Behavioral Needs checklist in order to receive one of the state-funded waivers.

### ***Are there caps on costs?***

Yes. Annual cost caps are \$25,000 for children and \$40,000 for adults, with some service-specific limitations built in to the waiver as well. Annual limits will be reevaluated after the waiver becomes operational to determine appropriateness.

### ***Will participant direction be required?***

Yes. Everyone on this waiver will be required to engage in participant direction for at least one service. Two components of participant direction are offered on the waiver: budget authority and employer authority.

Budget authority allows an individual to allocate the budget to waiver services however he or she chooses, and to manage the budget accordingly.

Employer authority allows the individual to manage (including hiring and firing) the workers. The individual can either serve directly as the employer of record or enter into an arrangement whereby a third party (e.g., a provider agency) is the employer of record.

### ***Will a support broker be available to assist an individual?***

Yes, if an individual voluntarily chooses to have a support broker and pays for this service out of the funding allocation. A support broker may serve as the agent of the individual, advising and assisting in coordination of services as well as helping explain responsibilities related to selecting service providers and negotiating rates. Support brokers must meet required qualifications.
