## Best Buddies opens state office

Columbus, OH, Feb. 4, 2016--- Best Buddies International, a groundbreaking nonprofit founded in 1989 by Anthony K. Shriver to establish a global volunteer movement that creates opportunities for one-to-one friendships, integrated employment and leadership development for people with intellectual and developmental disabilities, is excited to announce the opening of its newest office in the state of Ohio.

The Best Buddies Ohio office will be located in Columbus and will work to expand Best Buddies programs in schools and communities throughout the state while providing support to existing chapters in Ohio (Ohio State University, Miami University, University of Dayton, Grandview Heights High School, Hamilton High School, and Kings Run Middle School).

"We are thrilled to have the opportunity to expand the Best Buddies mission of friendship and social inclusion throughout the state of Ohio," said Anthony K. Shriver, Founder and Chairman of Best Buddies International. "The team in Ohio has done an amazing job laying the foundation for their state office and I couldn't be more proud of them. Best Buddies programs of friendship, leadership development and integrated employment will undoubtedly create positive change for the thousands of people throughout the state of Ohio with intellectual and developmental disabilities."



Janet Callison was selected as State Director after spearheading efforts to open the office for the past two years. Callison was inspired to establish Best Buddies in Ohio because of her son, Silas, age 15 with Down syndrome. Beth Savage, FCBDD Board member serves as the Chair of the Best Buddies Ohio Advisory Board.

"Best Buddies brings out the best in all of us. The organization was founded on the premise that each one of us, no matter our abilities, has what it takes to be a friend, a classmate, a co-worker and a valued member of their community," said Callison. "Because of the generosity of people throughout the state, the diligent leadership of our Expansion Board, and the support of Best Buddies International, Best Buddies Ohio can now facilitate opportunities that will absolutely change lives."

The opening of the state office will be celebrated at the upcoming Best Buddies Ohio Gala "OH! What a Night!" on April 16, 2016 at the Ohio Statehouse.

## Early Intervention legislation

The Ohio Department of Health and the Ohio Department of Developmental Disabilities are pursuing legislation to change lead agency status to the Ohio Department of Developmental Disabilities (DODD) from the Ohio Department of Health (ODH).

While the two state departments have worked together for many years, the bifurcated nature of the current system has resulted in some confusion. This transition is designed to improve communication with as little disruption as possible. Diane Fox will oversee the new technical assistance/ training team.

According to John Martin, Director of DODD and Rick Hodges, Director of ODH, "the Help Me Grow Advisory Council and EI Stakeholder group will continue to meet and advise on federally mandated Part C work and this transition." ## Employment First grant

The FCBDD adult services department has been selected along with four other providers in Ohio to receive a grant from The Ohio Department of Developmental Disabilities and Employment First.

The grant, called the Integrated Community Support Start-up Grant, will provide funding to assist the Adult Services Department in the transition from facility to community-based service supports over the next several years. It will fund a process of present to future state mapping which will lay out a "roadmap" of transition action steps and timelines for the department. The grant will also support the development of a demonstration project to serve as a model for individualized community-based day services as well as for the transition of facility-based adult services staff to community-based service supports.

Bob Gaston, Director of Adult Services commented that "we are pleased to have been selected to participate in this opportunity to create positive change in the supports provided by FCBDD for people here in Franklin County."

# Employment discussed at OSDA

City and State officials attended a recent meeting of the Central Ohio Self Determination Association (OSDA) to discuss employment issues.

Newly elected Columbus City Council member Michael Stinziano indicated he came to listen and hear concerns. Councilman Stinziano was previously a member of the Ohio House of Representatives, where he provided active support of Project STIR (Steps Toward Independence and Responsibility) and other legislative initiatives.

Zach Haughwout and Tom Hess represented the Ohio Department of Developmental Disabilities (DODD) to seek feedback and to provide guidance on paths to employment. Kristen Helling, Assistant Deputy Director of BVR with Opportunities for Ohioans with Disabilities (OOD) provided additional insights on how to work with OOD or BVR counselors who can assist with employment.

Self-Advocates shared their personal stories and provided state officials with their suggestions on supports that are needed. Some emphasized the importance of having support to secure employment as well as the importance of providing individuals with choice to pursue their interests.




