Free parking, on-site cafeteria, and continuous entertainment are also planned. The Rhodes Center will also allow for space for individuals to have more private interviews/ conversations with Providers as they determine who can best meet their needs.

Provider compliance reviews posted

The Ohio Department of Developmental Disabilities (DODD) has announced that it will now post provider compliance reviews on their website at http://dodd.ohio.gov.

Compliance reviews are required to ensure that providers comply with all federal and state regulations, including Medicaid requirements. Reviews may be completed on a one, two or three year cycle.

Individuals, family members or others are encouraged to check the reviews when selecting their provider. The reports are posted in the Provider Search feature of the DODD website.

Reports for 2013 and 2014 are online and new reports will be posted as they are completed. Earlier reports are available by request.
