Board endorses ADAMH levy - Issue 14

The Franklin County Board of Developmental Disabilities (FCBDD) has officially endorsed Issue 14, the 5 year renewal levy for the Alcohol, Drug and Mental Health (ADAMH) Board.

Because this is a renewal, it will not increase taxes. David Royer, ADAMH CEO stated this levy would not begin collection until 2017.



Jed Morison, Superintendent/CEO of FCBDD stated that ADAMH has been a strong partner, supporting services for people who have mental illness and developmental disabilities.

Partnerships include support for the Nisonger Center dual diagnosis program, behavioral support services for children and increased awareness efforts related to mental health and disability. The two agencies also collaborate as members of the Franklin County Family and Children First Council.

Issue 14 will be on the November 3rd general election ballot.



"The Hero Within"


October 9 through November 11 at the Cultural Arts Center

State funded waiver allocation process set

A plan to allocate the 3,000 new state-funded waivers has been set, based on funding allocated in the FY 2016-17 state budget.

The 3,000 state-funded waivers are to bring down the waiting list, and to give individuals considering or living in an Intermediate Care Facility (ICF) the option to live in the community with a waiver.

With the funding approved, a work group representing County Boards, providers, individuals and families, and DODD staff was formed to develop a plan to distribute the waivers.

"There were many ways we could have approached the distribution of these waivers, and the group arrived at a fair, objective method," said John Martin, Director of DODD. "The plan ensures every county receives some waivers, and that we're advancing the state as a whole."

The following is a summary of the statewide projected waiver distribution:

- 400 Diversion Waivers: These waivers will offer individuals who are considering moving into an ICF the option to live in a community setting with waiver supports. Prior to admission to an ICF, individuals will learn about the option of a waiver.
- 800 Exit Waivers: These waivers will help individuals who currently live in an ICF and want to leave to do so. A third party will interview individuals in ICFs who also are on the waiting list to determine if they still want a waiver.

- 1,864 Waiting List Waivers: These waivers will bring down the waiting list; currently, there are 40,000 on the state waiting list, about 20,000 of whom are projected to have an immediate need. The 1,864 waivers for the waiting list will be comprised of 1,000 SELF Waivers and 864 Individual Options (IO) Waivers.

"We're excited that Governor Kasich and the legislature supported expanding services by adding state funding for waivers," Director Martin said. "We hope that demonstrating the impact this has on individuals and responsibly managing this process will pave the way for future increases."

Every county will receive at least three waivers - one SELF Waiver, and two Individual Options (IO) Waivers.

If a County Board isn't able to use their waivers, the waivers will be redistributed to other counties.

It's very important that all waivers are distributed by June 30, 2017 which will help DODD request additional funding to increase waiver enrollment in the future.

Waivers will be distributed evenly over the next two years to manage cost increases and the workload of County Boards. The first group of individuals should be enrolled later this fall, and all waivers will be distributed by the end of the biennium (June 30, 2017).

The Ohio Department of Developmental Disabilities will monitor the both the number and pace of the waiver distribution to ensure individuals are enrolled in all of the waivers.

PIECE Project successful

The Pre-Vocational Integrated Education and Campus Experience (PIECE) pilot project was a big success according to representatives of Franklin County Board of Developmental Disabilities (FCBDD) and The Ohio State University.

The 10 week campus experience for adults served by FCBDD provided career discovery and assessment, job shadowing, internships and instruction. FCBDD staff were also able to share their perspectives and learn with OSU personnel.

Closing ceremonies were held at the Ross Heart Hospital and all participants provided a recorded presentation of their experiences, with several staff adding their remarks.

Superintendent Jed Morison commended participants, families and staff from FCBDD and the University for their outstanding work and their willingness to 'step out of the box' by trying something new. "We can build on this experience and will hope we can repeat next year."

Bob Gaston, FCBDD Adult Services Director initiated the project with Dr. Margo Izzo, Program Director at the Nisonger Center. Natalie Herman, Training Supervisor at ARC North, provided excellent leadership on a daily basis.

The 'Call it Quits' line provides counseling for uninsured Ohioans, Medicaid recipients and pregnant women. By calling 1 -800-QUIT-NOW (1-800-784-8669), one can receive advice, a personalized Quit Plan, the latest information about medications that can help you quit and free nicotine patches.

She says, "I'm proud of the good work that we do in the Job Placement Division. I work with a lot of compassionate people. The best part of my day is spending time with my consumers." Maggie also has appreciated the team work with specialists from the workshops over the years, including Anne Thomas of the Psychology Department; Doug Smith, Rehab Engineer; and Debbie Wright, Occupational Therapist.

Maggie has been married to Carl Scott of the FCBDD Print Shop since 1982. In retirement, Maggie plans to volunteer in daughter Katie's third grade classroom. She will also help daughter Erin with her new firm called the Generate Consulting Group, a consulting advisory firm for nonprofits and businesses.

According to Jed Morison, Superintendent/ CEO, "Maggie Scott has been terrific. Hundreds of people are now employed because of Maggie and hundreds more are better off having known and worked with such a wonderful person."





Legacy to benefit others

Some individuals who qualify for Medicaid have had a Medicaid Supplemental Services Trust fund established for them. The individuals' friends and family can make contributions to the trust, and the money does not count toward Medicaid eligibility.

About the only limit on spending the trust fund money is that it must be spent on things that the individual wants, and must be spent on things for which government programs will not pay. However, if an individual with such a Trust, who is also eligible for county board services passes away, any money left in the Trust eventually reverts to the county board, as a legacy to other individuals served by the county board.

Recently, such a sad situation has occurred, with the remaining legacy trust fund money reverting to FCBDD. FCBDD is intending to spend almost all of this one-time money by paying payee-ship fees for about 600 Individuals served by FCBDD who have to pay their own monthly payee-ship fees.

These 600 individuals have special payee-ships because they have no available family, or guardian to help them manage their money. These eligible individuals will receive notice in writing regarding arrangements for this one-time reimbursement.
