


## Remembering Robert Albright



**Robert Albright**

Attorney Robert Albright, who served as a member of the board of trustees of Creative Housing, Inc., from its founding in 1991 through February of this year, passed away on November 12th.

Admitted to the bar in 1950, he was a founding partner of the law firm of Lucas, Prendergast, Albright, Gibson and Newman. His specialties were Real Estate, Wills and Probate, and Business Law.

In addition to his service with Creative Housing, Mr. Albright served for many years as Treasurer of the Committee for Persons with Developmental Disabilities, and as an official in the sport of swimming with both the Ohio High School Athletics Association and the Ohio

Special Olympics. He was a Marine Corps veteran.

In January, Creative Housing's board of trustees named the main conference room at its offices at 2233 Citygate Drive in Mr. Albright's honor. Creative's President Pat Rafter commented, "Bob was one of the driving forces behind the creation of Creative Housing. He was also a great mentor and supporter."

FCBDD Superintendent Jed Morison added, "Bob was truly a special man, and was always willing to help."

Mr. Albright was survived by his daughter, Katie Hamilton, and a sister.

## Agency poised to retain CCC bragging rights

As the 2013 Combined Charitable Campaign neared its conclusion, overall coordinator Jack Beatty was not quite ready to proclaim victory. But evidence strongly suggested that FCBDD would continue its long tradition of leading all Franklin county agencies in funds raised.

"Our staff have been remarkably generous," he said. "The coordinators have been tireless. It has been a privilege to be part of this team."

As of November 21st, the total amount raised was nearly \$98,000. Service Coordination held the lead among all departments with \$18,305.

The campaign encouraged staff to use payroll deduction for donations. For the first time staff could fill out pledges electronically as well as through printed forms.

The following departments showed 100 percent staff participation: Administration and Support Services, Bixby Living Skills Center, ESD On-site Crews and Psychology.



## Dale DiLeo visits Franklin County by Teresa Kobelt



In November, ARC Industries hosted Dale DiLeo, an internationally recognized speaker, consultant, and advocate for people with disabilities. Dale is the Past President of the Association of People Supporting Employment First (APSE), and is the lead author of that organization's highly respected *Ethical Guidelines in Supported Employment*.

Dale spent three days in Franklin County: one with adult services staff; one with Franklin County board members, department heads, supervisors and staff from across the agency; and one with the ARC Industries board of trustees. He focused on "Building a Culture that Creates Job Success," and shared the history behind sheltered employment and the shift to integrated, community-based employment as a goal for all working-age adults.

Time was allowed for questions and answers and discussion about services in Franklin County, national trends, shifts in the service delivery system, litigation in the states of Oregon and Rhode Islands focusing on

sheltered employment, recent legislation in Massachusetts to phase out sheltered employment, and nationwide Employment First efforts. Some of Dale's key concepts were:

A job is a typical cultural expectation in our society, and is an important part of life for all us, including those with disabilities.

People with disabilities served in government-funded disability agencies should be expected to work in integrated settings. This should be the "default setting" of disability programs.

Research shows that when given the choice, most individuals choose community work, and that community employment is more cost-effective and has better outcomes than segregated services, including sheltered work.

Employment First is part of a greater movement related to self-determination, normalization, and integrated community life.

Dale will be back in Ohio next year to provide training to DODD, county boards and providers throughout the state.

## Advocates conduct statewide training

FCBDD advocates and their support allies were well represented at the statewide Project STIR training held November 4 through 7<sup>th</sup> at Deer Creek State Lodge in Mt. Sterling. Project STIR stands for "Steps Towards Independence and Responsibility."

Trainees are taught by self-advocates on speaking up for themselves, communicating assertively, problem solving, negotiating for themselves, knowing their rights and responsibilities, and how to access needed resources.

FCBDD Superintendent Jed Morison visited on the first day of training and was impressed at the organization and quality of the program. "The trainers did just an awesome job," he said.

The statewide trainers included Marci Straughter of ARC Industries South and Elizabeth Beu of FCBDD's Employment Services Department.

Marci's coach for the training was Jaime Graham, a Supervisor at ARC South. Jaime is also an Ohio Self Determination Association (OSDA) board member and coordinates the central region for Trainers for Statewide Project STIR.

Elizabeth Beu's mother, Nancy Beu, was her coach and support person for the training. Elizabeth works at the Columbus North YMCA.

Christine Brown of ARC West, a statewide self-advocate trainer, led the session on proposed legislation relating to people with disabilities. Christine maintains regular contact with state legislators.

# FCBDD earns maximum CARF accreditation

The Commission on Accreditation of Rehabilitation Facilities (CARF) has awarded FCBDD a 3-year accreditation, which is the longest term of accreditation granted by the organization.

CARF's survey team visited FCBDD September 16 through 18th. Their review covered six areas of the agency's services for adults.

CARF complimented the agency's "visionary and engaged leadership," noting that agency leaders are "proactively positioning the organization to navigate through system changes such as the Olmstead decision, employment first initiatives and minimum wage increases."

The report praised FCBDD for "its strong commitment to self-advocacy." Commendation was given also for "developing a strong business advisory council."

Commenting on the results of the survey, Superintendent Jed Morison said, "It is fantastic news, and a great credit to our staff and board."

In preparation for the CARF review, FCBDD staff conducted a detailed self-review concerning each service area.

The new accreditation will extend through October, 2016.

## Staff volunteers participate in drill

Six members of FCBDD's "Ready When the Time Comes" volunteer program took part in a mock disaster drill on Saturday, November 9th. They were joined by 60 other volunteers and staff from the Columbus Red Cross. The program is managed by Columbus Red Cross to provide volunteers who are trained to work in shelters that would be open during a community crisis.

Since 2008, FCBDD has maintained a corps of more than 70 staff members who have been trained to operate a shelter for individuals with developmental disabilities and their families.

Plans exist to open shelter facilities and provide specialized equipment as needed within West Central School, Northeast School and Bixby Living Skills Center. Thankfully, these provisions have not yet been needed as the Columbus area has been free of any crisis.

## Self-Advocacy conference a hit

Sixty-two consumers attended FCBDD's annual Self-Advocacy Conference, which was held at the Xenos Center, 1934 N. Fourth Street, on October 16th. The theme of the conference was "Rolling on the Wheels of Knowledge."



The conference highlighted the Employment First program and consumer benefits.

FCBDD's Director of Adult Services Teresa Kobelt discussed the Employment First initiative, including the national emphasis on employment opportunities for individuals with disabilities. Aaron Robinson, who has been working at his current job for over a year and had worked previously at ARC North, shared his story.

Tanya Chiles, Benefits Specialist for FCBDD, helped dispel some of the myths about workers losing benefits. She also explained the similarities and differences between Supplemental Security Income (SSI) and Social Security Disability Insurance (SSDI).

Most importantly, she urged all consumers to call her to have a benefit analysis completed.

# Provider fair well attended

FCBDD hosted a provider fair at the Aladdin Shrine Center at 3850 Stelzer Rd. on November 14th. The event, which lasted from 1 to 7 p.m., attracted approximately 1,000.

The aim of the fair was to provide individuals with developmental disabilities, as well as their families and caregivers, an opportunity to learn more about available services.

"We wanted to give folks the chance to meet some of our many providers and hopefully ease the stress of finding 'the right provider,'" said Lillian Beck, Service Coordinator and member of the event's planning committee.

A total of 110 providers set up information booths at the fair, representing a wide variety of waiver services. The booths displayed helium balloons that were color-coded to make it easier to find different types of offerings.

Parent John Bickley found the fair "very worthwhile." He is a member of the FCBDD board.

The event was "so much fun," said Heather Whitt, an aide with I.B.A. Support Services. Provider Dorreetha Irby, owner of Loving Hearts, agreed. "I love that we have the opportunity to meet people and give out information."

The planning committee is hoping to gather feedback and then start working on the next provider fair.


