## Levy discussions continue

Plans are continuing for the Franklin County Board of Developmental Disabilities to be on the November 7, 2017 ballot for a renewal levy, representing **no new taxes**.

In February, the Board requested that the County Commissioners place the 3.5 mill renewal levy on the ballot. The Commissioners then requested their Human Services Levy Review Committee to review the levy proposal.

Superintendent/ CEO Jed Morison and Chief Business Officer, Dot Yeager have met with the Levy Review Committee twice to review the proposal and respond to questions. The committee will prepare their report and submit to the Commissioners.

Assuming that the Commissioners approve the request to be on the November ballot, they will ask County Auditor Mingo to officially certify the amount of

funds the levy will continue to generate. Following this, the Commissioners are expected to consider a resolution to request that the Board of Elections place the renewal levy on the ballot.

According to Superintendent Morison "this levy is needed to maintain basic, quality services for the children and adults of Franklin County who have developmental disabilities. It will allow us to continue to provide or support services, including early childhood education, services for school-age children, adult employment and habilitation services and special services such as Service Coordination, Transportation, Special Olympics and therapies."

Because this is a renewal, there is no increase in taxes. If approved the renewal levy would be for a ten year period.

## Advocates educate lawmakers

Over 100 self-advocates were present on April 7th to educate Central Ohio legislators on important issues related to the state budget and other laws.

The third Legislative Advocacy Day was held at the Bixby Center in Groveport with fourteen legislators or their staff in attendance. The event was sponsored by the Franklin County Board of Developmental Disabilities Self-Advocate Advisory Council.

Christine Brown, Event Coordinator said "this was the best ever. We really had a good turnout and chance to educate our legislators on topics such as Medicaid waivers, remote monitoring, employment first and college tuition costs."

Superintendent/ CEO Jed Morison welcomed the legislators and crowd and commended Christine Brown on the great job pulling the event together. In addition to the legislators, many other officials, including Director John Martin, were also present.

State Representative Hearcel Craig surprised the audience with the presentation of a commendation to the Franklin County Board of Developmental Disabilities on the occasion of the Board's 50th Anniversary. Representative Craig congratulated the Board on its "noteworthy record of accomplishment and unfaltering dedication to service and achievement."

The first Legislative Advocacy Day was held in 2013, then again in 2015. The Self-Advocate Advisory Council suggested these years to correspond with state budget discussion.

## DRO and Nationwide partner

Disability Rights Ohio (DRO) and Nationwide Insurance have announced a new partnership designed to provide free legal services to Ohio families and children with disabilities. The partnership will help bring much needed legal support to people struggling to obtain access to adequate healthcare services and medical equipment.

The project will pair volunteer attorneys and paralegals from Nationwide Insurance with eligible clients entangled in the legal complexities of the Medicaid appeals process. DRO staff will work collaboratively with the Nationwide volunteer team to train, screen and refer eligible clients and provide case preparation and ongoing support.

"DRO is excited to partner with Nationwide on this program," says DRO Executive Director Michael Kirkman. "We know there is a high demand for legal assistance with Medicaid hearings, and partnerships like this will allow us to expand our capacity and support more Ohioans."

"Nationwide is proud to partner with Disability Rights Ohio. Our legal department is staffed with compassionate professionals anxious to contribute their time and talents to those needing access to certain legal services," said Mark Howard, executive vice president and chief legal officer at Nationwide.

The project began on April 1st. It has entitled Tom to have enough funds to be independent and receive the care he needs."*

## DSACO sponsors *iCan Bike*

The Down Syndrome Association of Central Ohio (DSACO) is partnering with iCan Shine, a national organization that facilitates bike camps for individuals with special needs. DSACO is partnering with Nationwide Children's Hospital and the Autism Society of Central Ohio to conduct the camps.

This unique approach enables those with disabilities to become independent bicycle riders. *iCan Bike* is the perfect program for individuals at least 8-years old who want to learn to ride a two-wheel bicycle.

The *iCan Bike* staff who will travel to Columbus to implement the camp are highly trained. Both a Floor Supervisor and a Bike Technician will be on hand to ensure that campers are using the right bike for their size, strength and ability; are being assisted properly by the volunteers; and are safe.

Each camper will be assigned two volunteer spotters that will walk and run as the camper pedals. Last year these volunteers included siblings, therapists, aides, and college and high school volunteers. Volunteers must be at least 16 years of age and must be physically capable of running to keep up with the bikes. The two spotters take turns running and resting.

## COTA launches redesigned bus network May 1st

Bus service throughout the region will be enhanced when the Central Ohio Transit Authority (COTA) launches a redesigned bus network on May 1.

The redesign is a complete overhaul of the COTA network that will provide simplified routes, increased frequency, connections to more places, reduced bus congestion downtown, and service to more jobs.

"We believe the redesign will provide better transit service to the community," said W. Curtis Stitt, COTA President/CEO. "The new COTA network will have twice as many high-frequency bus routes that arrive every 15 minutes, and service will operate on consistent schedules seven days a week."

Signs are being placed at every bus stop in COTA's system notifying customers of service changes that will occur on May 1. Customers are encouraged to use the Trip Planner on COTA's website at [COTA.com](http://COTA.com)/TSR to plan their new trip beginning on May 1.
