## Agency moved forward in 2008

If a song title were selected to sum up the discussion at FCBMRDD's senior staff meeting on December 16th, the 2007 hit *Let's See How Far We've Come* by Matchbox Twenty would be a fitting choice.

Staff members, per the request of Superintendent Jed Morison, cited the top accomplishments for the agency in 2008.

Some of the items mentioned were:

- Secured passage of Issue 29, the MRDD levy, to allow for continued stability in services and staffing.
- Met Managing for Results measures.

- Enrolled many individuals on Medicaid waivers.
- Implemented new waiver reimbursement system.
- Received *LifeWorks* grant to promote employment from Rehabilitation Services Commission.
- Maintained 98% success rate for students taking Ohio Proficiency Test Alternate Assessments.
- Streamlined staff health insurance benefits.
- Established "Green Team" to promote environmental awareness.
- Restructured computer network to increase security.

- Developed emergency shelter agreement with Central Ohio Red Cross to serve persons with developmental disabilities, and trained 70 volunteers.

- Raised record amount for Combined Charitable Campaign.

Superintendent Morison concluded the discussion noting: "While we still have much to do, we can be proud of our accomplishments in 2008. This success is due to the outstanding, cooperative efforts of staff, volunteers, providers, individuals and families."

**Departing board members honored**

Three members of the Franklin County Board of MRDD were recognized for their service to the county at the November 20th meeting of the Board.

Mildred Blumenfeld, Paul Coppel and Ben Hale will end their tenures as Board members next month.

Ms. Blumenfeld was appointed to the board in 1987 and served as its President in 2004 and 2005. She has previously chaired the boards of ARC, Scholastic, Council for Handicapped Children and Franklin County Residential Services.

Mr. Blumenfeld has worked to improve clients' health through better nutrition and has efforts to obtain air conditioning of county buses.

Paul Coppel was appointed to the board in 1997 and served as President in 2002 and 2003.

A lawyer and business man, Mr. Coppel brought a business, practical approach to board deliberations. He stressed the need for fiscal controls and provided valuable guidance on personnel and facility-related issues.

Ben Hale is the longest serving board member in FCBMRDD history having served since 1981 to 1990, and again from 1997 to the present. He served as Chairman from 1988 to 1990, and as President from 2007 through the present.

Mr. Hale provided leadership in developing residential options, ranging from the county's SCMR facilities to independent living arrangements through Creative Housing, Inc.

All three board members earned reputations as strong advocates for clients, staff and the general public.

Commenting on the board members, Superintendent Jed Morison said: "They help are exceptional public servants. We have been very fortunate to have them on our staff."

## Rose parade in sight for marching band


