Vote on Issue 22 set for November 8

FCBDD's 3.5 mill replacement levy, which will go before county voters on November 8th, is critically important.

Passage of the levy, known as Issue 22, is necessary for FCBDD to continue to provide basic services for six more years. These services are provided to over 16,000 children and adults with developmental disabilities.

Issue 22 Campaign Chairman Bill Wilkins praised FCBDD's work. "They have an outstanding track record of balancing the need to take care of these 16,000 people with the need to watch the bottom line," he said.



The 3.5 mill replacement levy will replace a 3.5 mill levy that expires next year. More details on the levy will be available on the following website: VoteFORIssue22.org.

Regarding the levy campaign, Superintendent Jed Morison was cautiously optimistic, "We are off to a good start and expect good support from our community." He added that a literature distribution will be conducted in the final ten days of the campaign, in which over 200,000 leaflets will be distributed door-to-door.

"It's about giving back!" is charitable theme

The annual drive asks agency employees to contribute money to charitable causes of their choice. Last year FCBDD led all the Franklin County agencies in funds contributed.

The campaign will run through October 28th.

Overall coordinator of the 2011 campaign is Jennifer Schueneman. "Our staff have a great record of supporting the campaign. We're hoping for another strong showing," Jennifer said.



Adult services planning continues

As program enrollment, philosophies, rules and funding evolve and change, planning for adult services continues for ARC Industries and FCBDD.

Under the direction of Marcy Samuel, Director of Program Operations, and John Mitchem, Director of Adult Services/ CEO ARC Indsutries, the Adult Services directors have been discussing the future. As Board member Jean Williams asked "what will we be in several years?" Discussions have centered on several factors that will influence future services,

Funding

One of those factors is funding, so future plans will also relate to "Stability 2011" planning. The recent state budget resulted in reductions of almost \$5 million in state subsidies and an estimated projected loss of over \$20 million in tangible personal property tax replacement funding. Superintendent Jed Morison states that our goal must be to "preserve basic services and our hope is to do this without layoffs if we plan far enough ahead."

Olmstead

State and federal pressures are also influencing future direction. According to State Director John Martin, the Federal Department of Justice has recently questioned "Sheltered Workshops" in some states, indicating that "segregated" settings may not be consistent with the intent of Olmstead. Olmstead was a lawsuit where the Supreme Court ruled that unnecessary segregation of individuals with disabilities violates the Americans with Disabilities Act (ADA).

Issues and Factors

Employment First Initiative

According to Marcy Samuel, the concept of "Employment First" has been adopted by many states and is now an initiative of the Ohio Department of Developmental Disabilities. Individuals are encouraged to seek community *employment first*, before considering sheltered employment.

While ARC Industries Sheltered Workshops continue to be an important alternative, increased emphasis is being placed on transitioning from school directly to employment. Future state and federal rules and incentives are expected to encourage more community employment.

Enrollment Shifts

One other factor that is influencing future planning is enrollment trends. Now that many private Medicaid providers are offering habilitation and employment services, there are more choices for adults. ARC Industries and the Living Skills Centers are no longer "the only game in town!" This has resulted in some enrollment shifts from our adult services programs to other community-based programs, all of which are funded with Medicaid and FCBDD dollars.

Future Plans

What does this all mean to FCBDD, ARC Industries, and the Living Skills Centers? According to Superintendent Morison, it means we need to continue to proactively customize our services to meet needs, to fill gaps where services are needed and to partner with other community organizations. History suggests that our services in the future may be quite different. If we don't gradually change and adapt to all these factors, we may have much less control of our options in the future. We expect to continue to serve more people, just in different ways.

Based on these trends, the Adult Service's Directors have developed several ideas for future consideration and are now asking for input and suggestions from those we serve, their families and staff. Following input, decisions will be made regarding future plans, including implementation and timelines. - Recognizing that less than 25% of ARC Industries individuals and staff purchase lunches, should the food service operations of ARC Industries be closed?
- Should the current Workshops become more specialized, with one or two focused on work, one focused on the arts, gardening and retail and another focused on habilitation?
- If enrollment in the adult services declines, should one location close?

- If one location closes, should the ARC Industries Business Office be relocated to that building, recognizing that the Marilyn Lane building is leased?
- Should ARC Industries establish some smaller, agency-owned businesses in the community and if so, what types of businesses (e.g. café or art studio)?
- Should some staff throughout adult services be redeployed to support community employment as the need arises?
- Should greater emphasis be placed on training individuals to use public transportation to enhance their independence?
- Should an *employment first* initiative be initiated, with greater emphasis on career exploration and integrated work environments prior to placement in a workshop?

• What other suggestions do you have?

According to Marcy Samuel, it is important to remember that we are still in the planning stages and these ideas are listed to generate comment. Following input, more concrete proposals and timelines will be communicated.

Dr. Gee endorses levy_

The Ohio State University President Dr. E. Gordon Gee has announced his endorsement of Issue 22, the developmental disabilities replacement levy, which is on the November 8th ballot. An excerpt from Dr. Gee's letter follows:

The Ohio State University is proud to partner with the Franklin County Board of Developmental Disabilities in several capacities, most notably being the Board's work with Ohio State's Nisonger Center. The Nisonger Center provides vital services to our community members with developmental disabilities - including preschool programs and dental clinics - and support from the Board is crucial to the center's success.

The Board also plays a significant role in the wider Franklin County community. In 2010, the Board provided services to more than 16,000 children. The passage of Issue 22 is vital to the Board's continued good work.

Nisonger taking survey on Down syndrome

The Ohio State University Medical Center and Nisonger Center are working together to investigate the health of Ohioans with Down syndrome. Research shows that people with Down syndrome are at a higher risk for developing chronic health problems than the general population.

It has also been reported that people with Down syndrome have a more difficult time accessing appropriate medical services when they get sick, and sometimes physicians lack the appropriate training or comfort level in dealing with their unique needs. Nisonger Center is seeking participants to complete an online questionnaire to help assess the health characteristics and access to health care services of adults with Down syndrome. The information will allow researchers to see problems in current health care training of medical professionals.

If you are the parent or legal guardian, grandparent, adult sibling, or caregiver of an adult (over 18 years old) with Down syndrome, you are eligible to participate in this online health survey. Sample questions will include: "Does this person have a primary care doctor?" "When was this person's last cancer screening?" The questions should be completed regarding the adult with Down syndrome.
