
Bickley is retired from his position of CEO for the Central Ohio YMCA, however is again working with the YMCA on an interim basis. He also Chairs the Board's Human Resources Committee. Both Mrs. Craig and Mr. Bickley were appointed by the Franklin County Commissioners.

Past Board Presidents Dean Fadel and Helen Ninos continue their service on the Board. Beth Savage serves as Chair of the Finance Committee and Marie Crawford will continue her service as a member of both the Finance and Human Resources Committees.

In other business, the Board approved the Annual Action/ Strategic Plan and received updates on the State plan related to the CMS (Centers for Medicare and Medicaid Services) Transition Plan which is due to CMS in March.

School consolidation considered

A recent analysis of enrollment trends and referrals to the FCBDD school-age program has led to discussions about consolidating both schools into West Central School.

Jack Brownley, Director of Schools and Special Programs, has been asked to seek feedback and provide a report and recommendations to the Superintendent by March 15, 2015. Current projections for next year's enrollment for the two schools is 122 students. An additional ten classes are located in public school district buildings.

For many years, the sixteen school districts in Franklin County have continued to take more and more responsibility for developing school programs in their neighborhood schools. FCBDD currently partners with Reynoldsburg and Southwestern City Schools, where FCBDD teachers and instructor assistants provide

instruction in the school district buildings. FCBDD will continue to offer this collaborative model to other school districts.

While school enrollment has shifted, early childhood numbers have continued to show high demand. The Board's Early Childhood Education Department continues to partner with the Franklin County Family and Children First Council for the 'Help Me Grow' program, providing assessments and services to young children with developmental delays.

The Board is not expected to consider a decision on the consolidation of schools until this Spring. Suggestions and feedback regarding the possibility should be directed to Jack Brownley at jack.brownley@fcbdd.org or by calling (614) 342-5960. Feedback is requested by March 1st.

State finalizes Strategic Planning report

The Ohio Department of Developmental Disabilities (DODD) has finalized their Strategic Planning Leadership Group (SPLG) report and published the report on their website.

The report is the result of several months of meetings with representatives of various 'stakeholders' in the statewide developmental disabilities community. DODD Director John Martin stated that the 24 member group met monthly from November, 2013 through November, 2014 "to examine trends and issues, conduct in-depth analysis of data and learn about best practices." In addition, four open forums were held on topics such as the Centers for Medicare and Medicaid Services (CMS) rule, work opportunities and community living.

The final report highlights key strategic issues such as aging of people with developmental disabilities, waiting lists, workforce development and more. The final result of the report is a list of 24, ten-year benchmarks, which are expected to guide future policy discussions.

The ten-year benchmarks address three key areas:

- ◆ The experiences of people with developmental disabilities and their families
- ◆ Service delivery
- ◆ Infrastructure development

Just some of the specific ten-year benchmarks are as follows:

- ⇒ 90% of individuals newly-enrolled in waiver services will be planned enrollments, not emergencies
- ⇒ 25% of all DD waiver recipients will live in host homes, using technology and creative strategies for recruiting, matching and providing supports for success
- ⇒ The number of people employed will be 50% of adults served
- ⇒ The number of quality, affordable and accessible housing units in safe neighborhoods will increase by 25%
- ⇒ Nursing services will be in all waivers
- ⇒ The total number of ICF beds will be reduced by 50% to 2800 beds
- ⇒ All direct service professionals will earn a livable wage (200% of the poverty level) for all services provided to people with disabilities
- ⇒ 1500 people will leave ICF facilities of 16 beds or larger and move to community homes
- ⇒ A comprehensive DD waiver will be available

While not everyone on the leadership group agreed with all the benchmarks, at least 75% of those participating agreed on the benchmarks approved. DODD officials did not vote on the benchmarks.

According to Director Martin, "these 24 benchmarks provide a vision and a direction for our service delivery system. Our job as leaders is to manage these changes in responsible, planful ways that honor the choices and listen to the voices of those affected by these changes."

It is expected that some of the benchmarks will require additional funding and may result in state budget policy initiatives.

Human Services Levy Committee update

Superintendent Jed Morison and Dot Yeager, Chief Business Officer provided an update to the Human Services Levy Review Committee of the Franklin County Commissioners in January.

The Board was last on the ballot for a levy in 2011 and has committed to remain off the ballot until this levy expires in 2018. The Board may request a renewal vote in the Fall of 2017 or Spring or Fall of 2018.

The Levy Review Committee is Chaired by Jesse Hemphill of Hemphill and Associates. Other members of the committee include representatives from The Ohio State University, Nationwide Insurance, Franklin County Finance Authority and the National Affordable Housing Trust. Kenneth Wilson, Deputy County Administrator for Resource Management represents the Franklin County Board of Commissioners and Commissioners' staff

assigned to work with the committee includes Heidi Hallas, Justin Nahvi, Zak Talarek and Carla Wallace.

Superintendent Morison and Dot Yeager provided an update on services, finances and the status of progress on previous commitments. It was noted that FCBDD staffing has dropped from 1420 in 2010 to 1189 in 2014 to adjust to reductions in levy funding and enrollment shifts due to an increase in providers and 'free choice of provider' for Medicaid recipients.

Committee members commended the Board for maintaining stable services and finances during these challenging economic times. Committee Chair Jessie Hemphill said "we are pleased that the Board is fulfilling previous commitments including their promise to not request additional levy funding until their current levy expires."

ABLE Act signed

Federal legislation was signed by President Obama in December to allow for individuals with developmental disabilities to open special accounts where they can save up to \$100,000 without risking eligibility for Social Security, Medicaid or other government programs.

The ABLE Act (Achieving a Better Life Experience) is modeled after college 529 savings plans. Individuals must have a disability that originated prior to age 26 and a maximum of \$14,000 can be deposited into an ABLE account annually.

While the law was passed in December, 2014, states will now be required to establish regulations to implement the law. Funds accrued in ABLE accounts will be able to be used to pay for education, health care, housing, transportation or other expenses. As more details become available, updates will be provided in *Dateline*.
