Ben Hale remembered

Ben W. Hale, Jr., former President of the Franklin County Board of Developmental Disabilities, passed away on May 28, 2015.

According to Superintendent Morison, "Ben served longer than any other Board member and leaves an impressive legacy that will positively impact the lives of thousands of people for years to come."

Ben was first appointed to the Board in 1982, when he served for eight years. During his tenure, he provided the leadership to establish four residential sites located on Morse Road, Dierker Road, Kimberly Woods Parkway, and McDowell Road in Grove City.

In the 1980s, when some were resistant to having "group homes" in their neighborhoods, Ben came up with the novel idea to build our residential properties first and let the neighborhoods build up around us. His zoning and development expertise with his law firm of Smith and Hale, allowed him to know of sites where future development was likely to occur. The four sites developed included six, four bedroom apartments that are now funded with state and federal Medicaid funds.

Following his first eight years on the Board, Ben continued to volunteer, including his work to establish Creative Housing, Inc. On July 10, 1991, Creative Housing had their first corporate meeting with the following people present: Ben Hale, Roger Murphy, Bob Albright, Jed Morison, Martin Kerscher and Patrick Rafter. Ben Hale was the first Chair of the Board. Creative Housing now has over 400 properties in Franklin County that provide a home for people with developmental disabilities.

In 1997, Ben Hale was again appointed to the Franklin County Board of Developmental Disabilities by the County Commissioners. He would serve another twelve years, again serving as President for some of these years. During his second term, the Board passed levies in 1998, 2001 and 2008 and Ben provided additional leadership on statewide committees. In 2003, he was recognized by the Ohio Association of County Boards with its

Advocacy Award.

Ben Hale was a visionary leader with a generous and compasssionate spirit. He had a gift of bringing people together with solutions that will have a lasting impact.

CMS update on conflict free issue

The Ohio Department of Developmental Disabilities (DODD) has heard back from the Centers for Medicare and Medicaid Services (CMS) regarding the issue of "Conflict Free Case Management."

CMS has told state officials that County Boards of DD will have until March of 2024 to stop providing home and community based services directly. Since Case Management services are provided by County Boards, CMS has indicated it is a conflict if County Boards also provide home and community based services directly. Home and community based services are funded by Medicaid Waivers, including the IO, Level 1, SELF and TDD waivers.

CMS has also said that the State has until 2020 to reduce home and community based services provided by County Boards to no more than 30% of the services provided to individuals who are supported with Medicaid waivers. In other words, County Boards of DD will need to be sure that private Providers are serving 70% of the

ADA celebrates 25 years

The Americans with Disabilities Act (ADA) will celebrate 25 years on July 26, 2015.

In recognition of this, the Franklin County Board of Developmental Disabilities has passed a resolution to support events that are planned to recognize this landmark legislation. The ADA Columbus Planning Committee is scheduling a Community Welcome Reception on July 22nd at Columbus State Community College and on July 23rd, vendors, information tables and a special evening concert will be held at Columbus Commons.

The ADA Legislation was signed by President George H.W. Bush. The bill gives civil rights protections to individuals with disabilities similar to those provided to individuals on the basis of race, color, sex, national origin, age and religion.

Mike comes to the position after serving for nine years as Assistant Principal at West Central. His prior experience includes teaching, service as Lead Vocational Instructor at Goodwill Columbus, principal at Bishop Rosecrans High School in Zanesville and at Saint Vincent de Paul

Elementary School in Mt. Vernon. He has undergraduate and graduate degrees from Ashland University.

About his appointment to the Principal position, Mike said "I am excited about this opportunity and look forward to working with great staffs from both Northeast and West individuals who have Medicaid waivers by 2020 and 100% of the individuals by 2024.

This announcement will require the FCBDD Board and the ARC Board to consider future plans and timing on when home and community based services will be privatized. This primarily impacts adult services and adult transportation, which are both funded partially with Medicaid Home and Community Based waivers. This ruling does not apply to early childhood and school services.

According to Jed Morison, Superintendent/CEO "similar to when our residential services were privatized over 10 years ago, we are confident that services and staffing will be maintained in a stable and quality manner. In light of this, I have asked Dot Yeager and Marcy Samuel to head up our planning effort to develop recommendations on how we proceed. We are pleased that we will have more time to consider options."

FCBDD/ OSU vocational partnership

The Franklin County Board of Developmental Disabilities has entered into a unique partnership with The Ohio State University to provide career discovery, job shadowing, internships and instruction.

This Pre-Vocational Integrated Education and Campus Experience (PIECE) project is the first of its kind to help adults who are enrolled in facility based programs to explore community jobs or experiences.

An important feature of the program is also to provide Adult Services staff with ideas to prepare individuals for community experiences. The 10 week summer campus experience at The Ohio State University will include skill building and internships at the University. Twelve individuals are enrolled and six FCBDD staff are participating with University faculty, staff and students. Angie's List accepts providers

Angle's List has indicated that they will let Medicaid Providers of Home and Community Based Services register and create their own listing at no charge.

This will allow users of independent or agency Providers to rate those who provide their care and members of Angie's List will be able to review the Providers ratings.

According to Jed Morison, Superintendent/CEO of the Board of Developmental Disabilities, "this is a marketing tool for the Providers and a rating/review opportunity for individuals and family members."

Providers can create their listing at no charge by calling 1-866 -843-5478 to reach the Business Center or by going to <u>www.angieslistbusinesscenter.com</u>. It is likely they will be included in the home health care or home health aide listings. Providers should include 'developmental disabilities' in their listing so that they are easily found when one does a 'keyword' search.

Anyone can provide reviews of the Providers, whether members of Angie's List or not. Reviewers cannot be anonymous, however their name would only be released to the Provider they are reviewing and will not be listed publicly.

Project Stir
