The Special meeting of the Franklin County Board of Developmental Disabilities was called to order by Mr. Bickley, Secretary.

Christine Brown provided information regarding self-advocacy efforts in Franklin County and around Ohio. Christine will be making a trip to Washington DC in late October to speak with legislators regarding self-advocacy and other topics of interest.

RESOLUTIONS

- c) Ms. Crawford moved to award bid for renovation to 500 N. Hamilton Road, Gahanna to Palmetto Construction Services, LLC, for a base bid amount of \$754,677.00 and a contingency of \$76,000.00, second by Ms. Ninos. Motion carried unanimously.
- d) Ms. Ninos moved to award bid for vehicles to Ricart Ford at a vehicle cost of \$28,830.00 and extended warranty of \$1,740.00 each for three transit vans and a vehicle cost of \$21,200.00 and extended warranty of \$1,740.00 each for six transit-connect vans, second by Ms. Crawford. Motion carried unanimously.
- e) Mr. Fadel moved to go to bid for building improvements at 4395 Marketing Place, Groveport, second by Ms. Crawford. <u>Motion carried unanimously Motion carried unanimously.</u>
