## Adult Services planning continues

A proposed plan to integrate adult day services with adult transportation will be considered by the ARC Industries Board and the Franklin County Board of Developmental Disabilities in January.

The plan has been developed in response to the "Conflict Free Case Management" rule of the Centers for Medicare and Medicaid Services (CMS). This means that the Franklin County Board of Developmental Disabilities must privatize those services funded by Medicaid Waivers, such as adult services and adult transportation.

Under the proposed plan, ARC Industries would eventually provide transportation services for most who attend the ARC North, ARC East, ARC West, Northeast and Bixby Centers. Currently, some of the individuals supported at those Centers receive alternative transportation. Transportation to and from the buildings and into the community would be provided in smaller vehicles rather than large school buses, which would result in shorter routes and greater community access. In a memo to individuals served, families and staff, Superintendent/CEO Morison stated that "Adult Services management staff have indicated that they will give preference to current Adult Services and Transportation staff for the positions related to the integrated services."



While adult day services and adult transportation must be privatized, this rule does not apply to Early Childhood Education and School services because these services are not funded by Medicaid waivers. Transportation for early childhood and school programs is expected to continue being provided by the Franklin County Board of Developmental Disabilities.

Public hearings on the proposed plan to integrate adult day and adult transportation services will be held on January 9, 2018 at 5:00 p.m. and January 11, 2018 at 10:00 a.m. at 2879 Johnstown Road. The public is invited to attend.



He started in the 1970-71 school year as a teacher, served as Ohio's Director of Special Olympics in the 1970s and has served as Assistant Superintendent and Superintendent with the Board since 1977. In his community, he served on Bexley City Council for 14 years and volunteered in sports programs for over 30 years. He authored the "[Special Olympics Event Director's Guide](#)" for the Kennedy Foundation, the "[A Guide to Conducting Levy Campaigns](#)" for the Ohio Association of County Boards and "[Over 150 Years of History](#)" of services for persons with Developmental Disabilities.

In addition to testimonials offered by FCBDD staff, Christine Brown, Self Advocate, noted Jed's leadership in starting the Self-Advocate Advisory Council: "giving individuals the opportunity to speak out, as well as his support of Project STIR over the last three years." John Martin, Director of the Ohio Department of Developmental Disabilities described Jed as a "dignified, honest, kind leader, universally admired as the ultimate professional and statesman."

Linda Craig, President of FCBDD, credited his "visionary leadership as an unwavering testament as he works to enrich the lives of others, particularly those most vulnerable."

Dean Fadel, OACBDD Board President and FCBDD Board member, described Jed as "the best listener I have ever witnessed: whether a parent, senior staff or a member of the cleaning crew, Jed listens. It's one of the reasons FCBDD is stable and the programs are strongly backed by the local community."

Superintendent Morison was surprised by many of his staff who were in the audience. When the award was presented, they all held up 'Jed' placards.

In accepting the award, Superintendent Morison gave credit to others. He said "sometimes when a person heads an organization, he gets credit for what others have done. It's our awesome staff, the individuals we serve, their families and our providers who deserve this just as much for all their work and partnership over the years." He also said we still have lots to do and has no plans for retirement.

The OACB Annual Convention was well attended, with over 1100 in attendance over the 3-day period.

## Opiate use prevention resources

*Editor’s Note: There has been much news in Columbus and Ohio about the opiate crisis. Many individuals, family members, friends or others have been touched by this crisis. Columbus and Franklin County Public Health Departments have developed a resource guide to help educate people on the problem and provide resources for those who are impacted by opiate use and addiction. We have reprinted their information below.*

### What is Addiction?

**Addiction is a chronic, relapsing brain disease** that is characterized by compulsive drug seeking and use, despite harmful consequences.

**Drugs change the brain.** These changes can be long-lasting, and can lead to the harmful behaviors seen in people who abuse drugs.

### How to respond to an overdose:

- **Try to wake the person** up by yelling their name and rubbing the middle of their chest with your knuckles.
- **Call 911 and explain** that the person has stopped or is struggling to breath.
- **Make sure nothing is in the person’s mouth** that can block their breathing. If breathing has stopped or is very slow begin rescue breathing.
- **If possible, administer naloxone** (Narcan).

### What is Naloxone?

**Naloxone is a medicine** commonly known as Narcan that can be used to **reverse an overdose** caused by opioid drugs.

When administered during an overdose, naloxone blocks the effects of opioid on the brain and restores breathing.

It can be given as an **injection** in a muscle or as a **nasal spray**. Naloxone works rapidly and will not harm the person receiving it.

### How do you know when you’re ready to get help?

- Have you ever felt you should cut down your use?
- Have you ever felt guilty or bad about using?
- Have you ever been in trouble with the law, at school or work due to your use?
- Has your drug use caused problems at home with your spouse/partner or family?

### What are Opioids?

**Opiates are drugs that depress or relax the activity of the nervous system** which decrease feelings of pain and effects breathing.

**Opioids include drugs** such as heroin, oxycodone (Percocet, Percodan, OxyContin), hydrocodone (Vicodin, Lortab, Norco), fentanyl, hydromorphone (Dilaudid), buprenorphine (Subutex, Suboxone), codeine, methadone, morphine, and tramadol (Ultram).

### Signs of an overdose:

- Slow breathing (less than 1 breath every 5 seconds) or no breathing
- Vomiting
- Face is pale and clammy
- Blue lips, fingernails, or toenails
- Slow, erratic, or no pulse
- Snoring or gurgling noises while asleep or nodding off
- No response when you yell the person’s name or rub the middle of their chest with your knuckles

## How to Help Others:

An overdose is a medical emergency and **911** should be called immediately.

Early in 2017, FCBDD partnered with Add (The Association for the Developmentally Disabled) to complete the first Transition to Work (TTW) Summer Program that incorporated the Career Discovery Waiver Service.

Forty-five high school students from throughout Franklin County participated in the program. TTW's Discovery Team worked with the students to explore career options, identify work related interests, and pinpoint existing skill sets. Thirty-five local businesses welcomed TTW students, allowing their skills and talents to surface.

In September of 2017, each student received their individualized comprehensive Discovery Profile, which will aid them as they continue on their pathway to employment in our community.

## Calendars proposed

Calendars for the 2018-2019 program year have been drafted and will be considered by the Franklin County Board of Developmental Disabilities in their January 25, 2018 meeting.

The program calendar year has traditionally been from July 1st to June 30th, but next year it will be different with the privatization of adult services in January, 2019. The adult services calendar will only extend through December 31, 2018. The ARC Industries Board is expected to adopt calendars to be effective in January 1, 2019.

The proposed calendars for the Early Childhood and School programs have staff returning from summer break on August 20, 2018 with West Central students beginning on August 22, 2018 and early childhood children will begin their center based services following initial home visits and schedules communicated by the Early Childhood Education staff.

Winter recess for early childhood and school programs would be from December 21, 2018 through January 1, 2019 and Spring recess would be from April 22-29, 2019. School and early childhood calendars are similar to Columbus Public School calendars, however there are a few differences due to observance of some county holidays.
