Helen Ninos, Past President of the Franklin County Board of Developmental Disabilities attended her last Board meeting in January, after twelve years of outstanding service.

Helen was appointed to the Board in 2006 by the Franklin County Commissioners. As an attorney and executive with United Way, the Ohio Attorney General and currently with SERS (School Employees Retirement System), Helen has provided leadership through several of the Board's most challenging years.

Helen's leadership included service as Chair of the Human Resources and Ethics Committees and she held the offices of Secretary, Vice President and President.

During her tenure, three levies were passed in 2008, 2011 and 2017 allowing for continued stability in services for over 20,000 children and adults and their families. Her expertise in human resources and labor relations also resulted in stability in staffing, with no layoffs despite significant changes in Medicaid rules.

According to Superintendent/CEO Jed Morison, "Helen has been awesome. Her legal and administrative guidance has helped us all do our jobs better and her calm and logical approach to issues has carried us through some challenging times. It is people like Helen, who make this world a better place."

Boards approve Adult Services Plan

The Franklin County Board of Developmental Disabilities and the ARC Industries Board of Trustees have approved the plan to integrate adult day services with adult transportation.

The plan means that eventually transportation for most individuals to and from ARC North, ARC East, ARC West and the Northeast and Bixby Centers will be provided by ARC Industries. Implementation will begin later this year and finalized in 2019.

The plan is in response to the requirement of the Centers for Medicare and Medicaid Services (CMS) to have 'conflict free case management,' whereby the same organization cannot provide case management and services funded by Medicaid waivers. Adult Services and adult transportation are substantially funded by Medicaid waivers.

Transportation for early childhood and school services will continue to be provided by the Franklin County Board of Developmental Disabilities on school buses. Adult transportation will eventually transition to vans, allowing for shorter routes and greater flexibility for community experiences.

ARC Industries Business Office moves

The ARC Industries Business and Employment Services Offices have moved from their location at Marilyn Lane to 2780 Airport Drive.

Bob Gaston, CEO of ARC Industries said the move went smoothly, despite the inclement weather in mid-January. "Special thanks to Todd Surgoine, ARC Industries Business Manager, for the outstanding job he did coordinating the renovations of the leased space and the move."

The new location is located close to Cassidy Avenue, near the Airport Marriott. In addition to the offices, the new location includes more meeting space and parking.

The Marilyn Lane building will continue to be used for maintenance and storage, while plans are developed to move these functions to the former West Transportation Compound building.

Chris Lopez to retire

Christine Lopez, Assistant Director for the Service Coordination Department will retire at the end of February with 40 years of service.

Chris was one of the first staff members to begin 'case management' services for the Franklin County Board of Developmental Disabilities in 1986.

Initially, the Case Management Department (now called Service

Coordination) was established as a pilot project. Prior to this, case management services were provided by the Ohio Department of Developmental Disabilities.

According to Superintendent Morison, "Chris was one of the few pioneers who established the ground work for case management services in Ohio. As a Coordinator for the Model 50 Waiver and a MUI investigator in her early years, she helped to guide services and policy."

As a Supervisor and now Assistant Director for Service Coordination, "Chris has been a 'go-to' person for many staff and administrators. Her calm manner, her knowledge and her sense of fairness characterized her work and set an example for many."

Prior to her service with the Franklin County Board of Developmental Disabilities, Chris worked for APSI (Advocacy and Protective Services, Inc.) and she coordinated the Citizens Advocacy Program for the Franklin County Council for Retarded Citizens. While in college, she was a graphic artist for Chemical Abstracts.

About her career, Chris stated "It's been a pleasure working for the county board, it's offered lots of challenges, opportunities, and a myriad of varied experiences. I'm also very proud of the work we've done in Service Coordination and the role that I have played in making it what it is today."

While all retirement plans are not finalized, Chris knows that she plans to finish some projects around her house, spend more time with family – especially her 98-year old father. Chris also plans to travel and pursue some volunteer opportunities.

Bixby renovations complete

Renovations to Bixby Center were completed in January, after several months of enhancements.

According to Superintendent Jed Morison, "the staff at Bixby has been awesome and very flexible throughout all the construction." In addition to security enhancements in the front of the Center, the entire building received a new sprinkler system. When the building (formerly Southeast School) opened in 1974, sprinkler systems were not required.

Teresa Hall commended both staff and participants for their cooperation all these months. The project was done in phases so that services could continue. This required half of the building to relocate in phase one, and then again everyone moved for phase two, allowing contractors full access.

A first of its kind in service delivery

Bob Gaston, CEO of ARC Industries and Marcia Duffy, Operations Support Manager were on hand to represent ARC Industries at the recent Capital Improvement Funding Partnership award presentation.

ARC Industries received \$100,000 toward the purchase of a personal care vehicle. This state of the art service delivery concept will provide extended opportunities for person-centered, individualized community involvement and will provide individuals with complex needs the opportunity to build connections and friendships, and increase self-reliance.

The personal care vehicle will afford the means to attend to an individual's personal care/medical needs in a safe and private place and allow for the opportunity for more individuals to participate in meaningful community activities.

Thanks to the capital improvement combined funding partnership of The Columbus Foundation and the Osteopathic Heritage Foundation, ARC Industries was one of 22 local nonprofits selected to receive \$1,922,523 to invest in capital needs from facility expansion and renovation to technology upgrades and vehicle acquisition.

People with developmental disabilities and their families have repeatedly made their opinions clear: Ohio's waiting list for Medicaid Home and Community-Based Services (HCBS) waivers is overly complex and in need of simplification.

The current waiting list confuses people with developmental disabilities and their families, misleads advocates, and hinders efforts by policymakers to direct resources to where they are needed most.

That is why the Ohio Association of County Boards joined a coalition to modernize Ohio's failed waiting list.

This coalition includes groups representing people with developmental disabilities, parents, families, advocates, county boards of DD, providers, and the State of Ohio.

Through the efforts of this coalition and informed by the feedback of people with developmental disabilities and their families, we believe that a new approach to the way Ohio's HCBS waiver waiting list operates is needed. It's time to Fix the List.
