

Marcy Samuel announces retirement

Marcy Samuel, Director of Program Operations for the Franklin County Board of Developmental Disabilities (FCBDD), has announced that she will retire in March, 2019.

Marcy has devoted her career of over 45 years to supporting individuals with disabilities, including positions with the Bureau of Services for the Blind, Ohio Legal Rights, Marc Gold Associates and Goodwill Columbus, where she served as Vice President. In the 1970s, Marcy was the Director of what was then called ARCraft West and for the past 15 years, she has served as Director of Program Operations, overseeing all Departments providing direct services for the FCBDD. Marcy received her law degree from Capital University Law School.

Jed Morison, Superintendent and CEO of the Board stated that "Marcy is one of the most compassionate and reinforcing people I know. This, combined with her smart and logical approach to administering programs within budget, has allowed her to make advancements in every area. She has a fun sense of humor, can be tough at times and has always had the interest of those we serve, their families and staff first and foremost in every decision she makes. Adult Services/ARC Industries transition complete

Effective January 1, 2019, the transition of the Franklin County Board of Developmental Disabilities adult services to ARC Industries was complete.

This change, required by the Centers for Medicare and Medicaid Services (CMS) 'conflict free case management' rule, has been in process for the past 4 years, when the CMS requirement was announced. As a part of this, adult transportation services were also transitioned to ARC Industries, with a change from buses to vans and some transportation staff transferring to the ARC Industries facilities.

While the change impacted staff mostly, quality services will continue in a similar manner in the Adult facilities and throughout ARC Industries Employment Services. Staff are now employed by ARC Industries and transitioning staff have the option to maintain their same retirement system (OPERS), as required by law.

Jed Morison, Superintendent/CEO of FCBDD stated that the "ARC Industries Board, management leadership and the entire staff have done a remarkable job managing this transition with little disruption in services." ARC Industries will now bill Medicaid directly and has maintained a contract with FCBDD for individuals who do not have Medicaid and for other non-Medicaid services.

ARC Industries began as ARCraft Division of the Council for Retarded Citizens in October, 1963. ARCraft North Sheltered Workshop opened in November, 1963 on Indianola Avenue. ARCraft changed its name to ARC Industries in April, 1980.

Bob Gaston, CEO of ARC Industries commended staff "for all their outstanding work in making for a smooth transition. Both the ARC Industries and Franklin County Boards have been very supportive and have provided excellent leadership from day one."

Just some of the advancements that were initiated, led or supported by Marcy include the transition for Franklin County Residential Services, Inc. in 2005 and ARC Industries, Inc. in 2019 in response to rules of the Centers of Medicare and Medicaid Services; leadership resulting in top ratings with CARF, DODD Accreditation and Step Up to Quality; support of agency levy campaigns; and daily support for challenges or problems of individual staff or persons served by the Board. Marcy's law degree has helped immensely with interpretation of rules, laws and different state or federal initiatives and mandates.

Every individual, parent or staff member that she interacts with knows that Marcy's door was always open and her personal interest in people and many "acts of kindness" are well known to many.

According to Dot Yeager, Director of Business Operations for FCBDD, "It has been a true privilege to work alongside Marcy. She is a fierce advocate for those we serve and for all of our staff. She is an independent thinker and always keeps the 'big picture' in mind when making decisions."

Marcy will retire in March, 2019. About her career, she says, "the bedrock of what we do is the parents who started our services. We need to remember to advocate for individuals and their family members and to remind ourselves of their value and importance. I will miss the daily contact with everyone and am proud of the role I've played to keep quality services as the priority in every decision."

Partnerships continue

The Franklin County Board of Developmental Disabilities (FCBDD) and Franklin County Children Services (FCCS) have renewed their agreements to serve children eligible for both systems.

Jed Morison, Superintendent/CEO of FCBDD stated, "We value our relationship with FCCS, as we both support children who have developmental disabilities and also are eligible for FCCS services."

One partnership agreement spells out the responsibilities for the two organizations. It includes a provision that the Franklin County Board of Developmental Disabilities will reimburse Franklin County Children Services up to \$450,000 per year for services provided to children eligible for both agencies.

The second agreement renews a partnership with FCCS, FCBDD and ADAMH (Alcohol, Drug and Mental Health) Board to support up to four children who are eligible for services from from multiple agencies. This service is provided at Kimberly Woods, an Intermediate Care Facility for individuals who have developmental disabilities, operated by Boundless, Inc., The Franklin County Family and Children First Council also supports this service.

Jed Morison stated, "We are fortunate in Franklin County to have organizations that are willing to work together. I remember the days when we all pointed the finger at the other agency to provide the services."

Linda Craig elected to OACB Board

Linda Craig, Past President of the Franklin County Board of Developmental Disabilities, has been elected to a two-year term on the Ohio Association of County Boards (OACB), serving individuals who have developmental disabilities.

Linda has served on the Franklin County Board of Developmental Disabilities for eight years, including two as President of the Board. During her second year as President, the Board passed a ten-year renewal levy.

Linda will replace Dean Fadel, Past President and current member of the Franklin County Board. Dean has served on the OACB Board for twelve years during some of the most challenging years in our history. His service on OACB Board included two terms as president of the statewide organization.

Linda Craig is currently serving her third term as a member of the Franklin County Board of Developmental Disabilities. In her work, she serves as the Supervisor of the Customer Service Division of the Franklin County Treasurer's Office.

Karin Crabbe, Medicaid Waiver Services Manager for the Service Coordination Department of the Franklin County Board of Developmental Disabilities (FCBDD), was recently recognized with a statewide award from the Ohio Association of County Boards (OACB).

The "Partners in Excellence" Award was presented to Karin on November 29, 2018 at the OACB statewide convention for her work related to the revised Waiting List rule. Lori Stanfa, Service Policy Analyst for OACB, presented the award to Karin and three other staff members representing County Boards. In presenting the award, Lori stated that Karin and the others provided exemplary service for all their work assisting in the development of the rule and training to the field.

The revised Waiting List rule became effective in September. A new statewide assessment is now used to evaluate current or immediate needs. The previous rule was confusing and frustrating for many as it did not require an evaluation of need and people from all over the state could apply to be on the Franklin County waiting list, including those who are not even eligible for services from a County Board.

Jed Morison, Superintendent/CEO of FCBDD stated that "Karin has done exceptional work on the Waiting List, representing Franklin County and benefitting the entire state. And, the work continues now with implementation of the new rule."



Transition services presented at OCALICON

Lillian Beck, Transition Coordinator and Dr. Maryalice Turner, Principal at West Central School and Transition Services, recently represented the Franklin County Board of Developmental Disabilities (FCBDD) at OCALICON, the Nation's Premier Autism and Disabilities Conference.

Their topic was "Transition Skill Building & Opportunity, Charting a Course for the Future." There was wide interest in the topic, with numerous participants attending to learn more about how the Franklin County Board of Developmental Disabilities partners with community schools and businesses in preparing young people for their transition to adulthood. Their presentation focused on the Discovery Process, the school's options for students and the Transition to Work summer program.

This year's conference combined with the Special Education Leadership Institute and was held at the Columbus Convention Center with over 3000 in attendance from throughout the United States and some other countries.

Settlement agreement reached

A settlement agreement that has been reached in the longstanding *Doe v. State of Ohio* class action lawsuit will require efforts by the state to improve special education test scores and rates of inclusion in some Ohio school districts.

According to Disability Rights Ohio (DRO), the plan will include strategies for improving literacy and other supports for students and classroom teachers, such as evidence-based behavior support. The settlement will also provide additional help for students as they transition from high school to employment, further education and independent living.

"This settlement will create a court-enforceable plan that should open many doors of opportunity for students with disabilities who are currently shut out of a quality education in Ohio," said Kerstin Sjoberg, Director of Advocacy and Assistant Executive Director at DRO. "We are excited to join forces with the state to support student achievement on so many levels."
