DD Caucus established

Senators Andrew Brenner (Powell) and Nickie Antonio (Lakewood) have established the Ohio Developmental Disabilities (DD) Caucus to focus on issues supporting people with developmental disabilities.

According to Senator Brenner, this is a bipartisan effort, that "aims to bring many partners together to find innovative ways to better serve those with disabilities and their families."

The Caucus held its first meeting on April 16, 2019, where representatives of the General Assembly, state officials and advocates received an overview of the developmental disability system in Ohio.

Senator Antonio stated, "as a former special education teacher and advocate for the disability community, I am happy to join my colleague, Senator Brenner, in this new caucus. People who make up the disability community are an important part of the fabric of our society."

Spotlight on the MUI Department by Jack Beatty

The Franklin County Board of Developmental Disabilities has had responsibility for the investigation of major unusual incidents (MUI) since 1985. The current department consists of seven Investigative Agents, one Manager, and one Secretary.

Investigative Agents must be certified through the Ohio Department of Developmental Disabilities (DODD) which means completing the basic, state required training and then maintaining the credential through periodic in-service updates. Further, staff voluntarily complete course work at the Ohio Peace Officers Training Academy in report writing and interview techniques. They are seasoned, dedicated professionals and most have been doing this work for more than fifteen years.

Their investigative responsibilities are prescribed by a state rule (OAC 5123-17-02) which defines the various types of incidents and then describes how the administrative investigation must be conducted and documented by staff. The purpose of these investigations is to work with providers of service to gather and analyze information related to major unusual incidents so that actions can be taken to address any harm or risk to the individual and to prevent recurrence.

Generally, the process begins with a phone call (614-464-2743). Basic information regarding the incident is collected and immediate action is taken to ensure individual safety. The case is promptly assigned to an Investigative Agent who quickly arranges interviews with key people. Investigations are usually completed within thirty days. A summary report including a prevention plan is then sent to the individual/guardian, the provider, and the assigned Service Coordinator. Any allegations of a criminal nature are referred at the outset to the local law enforcement agency having jurisdiction.

These staff do critical work which results in better, safer services for individuals in Franklin County which is everyone's goal. But this work is not done in isolation and requires fostering good cooperation with providers of service. Regular email updates to agencies are planned to enhance communication as well as collaboration.

To search for a provider:

To find an agency provider, follow these steps:

1. Enter **ProviderGuidePlus.com** in the browser.
2. On the home page, click Search by Service.
3. Select your county, funding type and the service needed in the boxes provided.
4. Click the blue Search button.
5. On the search results page, agencies currently providing those services in your county will be listed beginning with the highest-ranked provider.
6. Click on a provider name to learn more about the agency and to read anonymous reviews.
7. You can save your favorite search results when you click Add to Favorites then follow the instructions to create a free account.

To rate and review a provider:

To submit a review, follow these steps:

1. Enter **ProviderGuidePlus.com** in the browser.
2. On the home page, click Find, Rate, or Review Provider.
3. Enter the county and agency provider's name in the boxes.
4. Click the blue Search button.
5. From the agency provider's page, click on the green box, Add an anonymous review.
6. Follow the instructions to create an account, or log in if you have an account.
7. On the review page, enter star ratings and say a few words about your experience with the agency provider.

With an emphasis on prevention, data is collected on MUI trends and patterns. It is reviewed yearly by a broad based committee composed of individuals, guardians, county board staff, and other stakeholders. Based on their assessment/discussion of the data, recommendations are made to improve the system and reduce the incidence of various major unusual incidents. The MUI Department is responsible for making certain that the recommendations are implemented.

Training is also a major focus. The MUI Rule requires that all staff receive training annually. This is particularly important this year as the MUI Rule was recently revised. Training is available on-line through the DODD website but the MUI staff also provide some live training opportunities. They also plan to produce a new video that will be made widely available.

Estate Planning Guide provides insights for Ohioans with Disabilities

The Ohio Developmental Disabilities Council (ODDC) has released a new book designed to improve understanding of the different strategies available for estate and special needs planning for individuals with disabilities, their families and others.

Planning for Bright Tomorrows: Estate and Future Planning for Ohioans with Disabilities and Those Who Love Them was authored by Dublin attorneys Logan K. Philipps and William K. Root. The book provides a complete overview of the different estate planning options available to families and individuals who have a disability.

Programs that people with disabilities rely on, such as Medicaid or Supplemental Security Income (SSI), include strict income and asset limits. According to Philipps, naming a loved one with a disability in a will or trust can upset the balance of income or assets available to that individual and may cause them more harm than good.

"Proper estate planning is important for the disability community. If done incorrectly, government benefits can be lost," said Philipps, who is an attorney at Resch, Root, Philipps, & Graham, an estate planning firm with a focus on helping people with disabilities and their families.


The book is an update and overhaul on a previous book released by the Ohio DD Council and includes changes to Medicaid, Trusts, and incorporates the new STABLE Account option available to individuals with disabilities.

"The goal of the book is to provide a non-technical explanation of what benefits are out there and to ensure how the individual or family member can keep them," added Root, who is also a parent of child with a disability.

Carolyn Knight, executive director of the Ohio DD Council, said the book was important because it illustrates how a lack of a plan can cause problems for a loved one with a disability.

"Every time a person with a disability or a family member is asked about a new program, their first question is always, 'how will this affect my current benefits'," said Knight. "Logan and Bill have done a masterful job of explaining these complex options in a way that families and individuals can understand."

STABLE accounts available

Ohio Treasurer Robert Sprauge continues to educate people on the value of Stable Accounts, which allow individuals with disabilities to save and invest without losing benefits such as Medicaid or SSI.

Individuals who developed disabilities before the age of 26 may be eligible to open an account. Funds can be put into five different saving and investment options, and investment earnings are tax-free when used to pay for qualified expenses. Qualified expenses include assistive technology, housing, basic living expenses, transportation, employment training, etc.

Accounts can be opened with as little as \$50 and accounts can be opened online by going to www.stableaccount.com. Participants can request a Stable Card that can be used to spend Stable funds and track expenses.
