Equipment, accommodations make voting accessible to all

As the new ADA coordinator at the Franklin County Board of Elections, Josiah Lanning wants people with disabilities to know that they can have the voting experience they want and need.



"We're working to build a bridge of communication," Lanning said. "The Board of Elections could have the best services in the world for individuals with disabilities, but if the people who need them don't know about them, are they really available?"

No matter a person's disability, Franklin County can provide a secure voting experience via absentee, early or Election Day voting, he said. Accessible voting equipment is available at all precincts. Staff members can assist, or voters may bring a helper if they cannot mark their ballot.

Lanning and others recently hosted an open house to answer questions and offer interactive voting demonstrations. Accessible voting machines feature audio ballots, Braille and tactile lettering, large print, high contrast and more. ASL interpreters are available at some locations.

"Today, many people have learned that through the accommodations available on our voting machines, they can have the same voting experience as anyone else," Lanning said during the open house. "We want them to know that equal access in the electoral process is a priority in Franklin County."



Terry Blosser is deaf-blind and generally has voted absentee, both in Ohio and Oregon. "I trusted my wife to mark what I wanted, even though we don't necessarily agree on everything," he said.

Now, after learning more about the equipment available in Ohio, Blosser is happy to have options for both absentee and in-person voting. "It's opening my eyes – no pun intended," he said with a smile. "Yes, it is."

Perspective: Start the conversation

Recently I read a book about ableism, specifically about ableism in the church. It included a nugget of research that is truly startling.

The author noted a 2018 study by the disability equality organization SCOPE that found 67% of people were uncomfortable talking to someone with a disability. Let that sink in. Two-thirds were afraid just to talk.

These past few years, I have been so frustrated that people on my caseload and others with disabilities often find it difficult to obtain employment - especially considering how very long ago (34 years!) the Americans with Disabilities Act became law. I had thought perhaps these employment struggles were an anomaly.

But alas, if people are uncomfortable speaking to those with disabilities, how in the world are they going to bring them onto their team, work with them on a daily basis, and make them a part of the team? How are employees with disabilities going to move up from entry-level jobs if it means working with even more people who aren't comfortable talking to them?

The answer I came up with is that people with disabilities, and their allies, may need to be starting the conversation. One of the reasons I use humor so much in my day-to-day life is, well, to stay sane. But humor also is a tool to make people comfortable talking to me. This is a residual effect of me feeling like an outcast and trying to put people at ease from the time I was a small child. I suppose it's also why I am not shy. But you don't necessarily have to use humor. You just need to start talking.

I want to honor the job developers who assist people with disabilities in finding and keeping jobs. They often start conversations with employers - who then realize the potential of a candidate they might otherwise have passed by.



Debbie New ending long happy career in ECE

Even after 44 years, Debbie New never has thought of her career as a job. She's more apt to describe her dedication to the Franklin County DD Early Childhood Education (ECE) program as a joy. "It's a love," she said.

New, an associate director for program operations, is retiring on October 4. She joined the agency as an occupational therapist and soon moved to ECE, where she helped oversee the development of a thriving, inclusive program and renovated building on Johnstown Road.

"This building is built for children," she said. "Every space is an opportunity."

Former ECE director Becky Love, who worked with New throughout their careers, said New is known for her hard work, kindness and loyalty to the agency. "We'd often

tease her that she wore rose-colored glasses," Love said. "But she really was so positive."

New and her husband plan to travel and to spend more time with their two grown children and six grandchildren. She said she's always thrilled to hear about progress and growth made by young children who took part in early intervention and early learning programs through the Early Childhood Education Partnership.



"Parents will tell us, when their kids go on to their schools, their children are the first to help others," New said. "And a lot of it's because of what they learn here."

Open Door breaks ground on new sensory park

An accessible play space with sensory equipment, a sports park and garden-framed outdoor theater will soon be available to people served by Open Door Columbus and the broader disability community.

The nonprofit disability provider recently hosted a groundbreaking celebration for the Mirolo Sensory Park, which supporters say will feature "life-changing pieces of sensory equipment."

Rebecca Sharp, Chief Executive at Open Door, said people served by her agency challenged leaders to break down barriers and create a wonderfully accessible, inclusive space for all to enjoy. "To see this come true, you're witnessing a dream," she said during the groundbreaking.

The Mirolo Charitable Foundation is contributing up to \$250,000 for the project, which will take shape next to Open Door and its intermediate care facility on the West Side. It's expected to be completed next year. Open Door says the park will provide opportunities for sensory stimulation and therapeutic resources, including space for outdoor events and performances.

Dot Yeager, Superintendent/CEO at Franklin County DD, spoke at the groundbreaking and said the project is a great example of "what it means to be person-centered. It's a pleasure to be here and to celebrate inclusion."
